You will need to upload several supporting documents as part of your application. We review these during our Due Diligence process if your application is successful. To help you prepare, here is what each document should include and look like.

1. Governing document

This could be your constitution, articles of association or similar.

What we expect:

- The document must be signed and show the date it was adopted.
- It should clearly state your organisation's purpose, how decisions are made, and your board/committee structure.
- If you are a CIC, it should include your asset lock.

2. Latest accounts

These help us understand your organisation's financial health and stability.

What we expect:

- Your most recent set of approved accounts (ideally from the last 12 months).
- Can be independently examined, audited, or management accounts depending on your size.
- Should show:
 - Income and expenditure
 - Reserves or cash position
 - Any restricted funds

3. A suitable safeguarding policy

Safeguarding is essential for any organisation working with young people.

What we expect:

- A policy that covers children and young people aged 11–25.
- Shows who your Designated Safeguarding Lead is and how concerns are reported.
- Includes procedures for:
 - Recognising and responding to safeguarding concerns
 - Managing allegations against staff or volunteers
 - Working safely online and in person
 - Safer recruitment
- Reviewed within the last 2 years.

4. A copy of your most recent bank statement

To verify your organisation's identity and financial setup.

What we expect:

- A statement dated within the last 3 months.
- Must show your organisation name, account number, sort code, and address.
- The name on the account must match your governing document.

We don't need to see your balance beyond confirming that the account is active.

5. Your organisation's logo

This is used only for communications if your application is successful.

What we expect:

- A high-quality PNG or JPEG file.
- Ideally on a transparent background, but not essential.
- If you don't have a logo, a simple wordmark (your organisation name in a clean font) is fine.

6. A photo that represents your organisation.

A clear image (with appropriate consent if young people appear) that shows your work, space, team or community.
